Lewis was a United Empire Loyalist and escaped to New Brunswick in 1783. First to Kennebecasis then to Millstream, Kings County.

Lewis and his brother Oliver served in the 2nd Battalion New Jersey Volunteers, and British Militia Unit. Along with Lewis & Oliver there was a James Frazee of Elizabethtown Essex Co. New Jersey. All three were mentioned in an advertisement from the Court of Common Pleas in 1778 for joining in with the British Army and other treasonable practices.

During or prior The American Revolution, Lewis & Oliver, his brother, Left the 13 colonies and went to Kennebecasis, New Brunswick, Canada. This is where Lewis petitions the authorities for a lot in 1788

After Lewis was marries to Catherine Thorne, they lived in Staten Island for a time. (pg264 Frazee Ancestry)

Land Grant as worded in Fredericton, New Brunswick. taken By Ruth Cole in 1984... George the Third by the grace of God of Great Briton, France and Ireland. King, Defender of the Faith and so forth. To all to whom these presents shall come. Greeting Know Ye, Than we of our special grace, certain knowledge and mere motion have given and Granted, and by these presents for us, our Hiers and successors, do give and grant unto Josiah Stone, John Watson, Robert Hustice, LEWIS FRASEE, Michael Butler, John Bough, Bernard Mullen, Jeremiah Maybee and Gilbert Merrit and their Heirs, an Island called Kennebecasis Island situated, laying and being in Kings County at the entrance of the Milkish Creek on the north side of Kennebecasis Bay River St John, laid out into ten lots of forty acres each more or less at right angles to a base line running north, sixty two degrees east. The lots number one, two, three, four and part of five being bounded by the waters of said bay on the west, north and south, and on the east by the western line of lot number six and the lots number six, seven, eight, nine and ten, part of five being bounded on the rear or south side by a ridge of rock running across the south east part of the island. To the east ward and the north ward by the waters of the said Bay and to the westward by the east line of lot number five containing in the

whole, five hundred acres more or less allowance being made for roads agreeable to the annexed plain wilderness land and hath such shape, form and marks as appear byte actual survey, thereof made under the direction of our Surveyor General of our said Province of which survey the plot here unto annexed is a representation together will all Woods, Underwoods, Timber, and Timber Trees, Lakes, Ponds, Fishing Waters, Water Courses Profits, Commodities, Appurtenances, and Hereditaments whatsoever thereunto belonging or in any wise appertaining together also with the privileges of Hunting, Fishing, and Fowling in and upon the same, and Mines and Minerals saving and reserving nevertheless to us, our Hiers and successors, all white Pine Trees if any such shall be found growing thereon and also saving and reserving for us our Hiers and successors all Mines of Gold, Silver, Copper, Lead, and Coals to have and to hold on said Island or Tract of Land containing five hundred acres, and all and singular other the premises here by granted onto the said Grantees their Heirs an assigns in manner and proportion following. That is to say, unto the said Josiah Stone the Lot number One. John Watson Lot number Two. Robert Hustice Lot number Three. LEWIS FRAZEE LOT NUMBER FOUR. Michael Butler Lot number Five. Joseph Wood Lot number Six. John Bought Lot number Seven. Bernard Mullen Lot number eight. Jeremiah Maybee Lot number Nine. Gilbert Morris the Lot number Ten. Each and every one of the said Lots containing fifty acres more or less severalty unto each of them and unto each other their several and respective heirs and assigns forever.
